A copy of said disclosures may also be viewed at the BANK'S website, www.palmettostatebank.com. The consent granted by this paragraph applies to all accounts identified in this agreement. BANK will notify CUSTOMER of any material change in hardware or software required for retrieving or storing this disclosure information.

- ** CUSTOMER understands their right to revoke this agreement and thereby withdraw consent to communicate with the BANK electronically.
